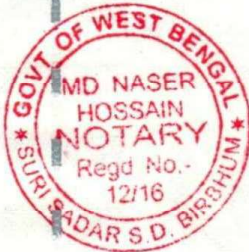

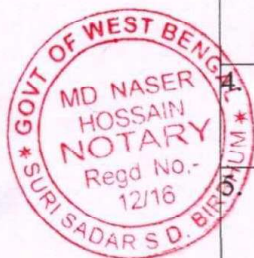



- The management of the institution shall discharge all the statutory duties relating to

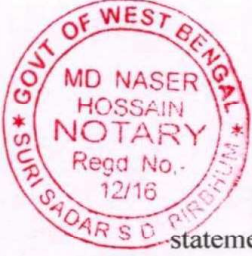

7. The information about staff has been verified from the original records submitted by the candidate and found correct.


